About Our Site

The Farms being used are working farm. Fields are a combination of woods and open although some are surrounded by barbed wire fences and include groundcover native to the area that occasionally is mowed. Some fields may have newly planted wheat.

Notes to Exhibitors

Chapter 3, Section 1, of the Tracking Regulations: "Eligibility. This test will be for dogs not less than six (6) months of age that are eligible for entry and that meet the requirements of the following Section 2.

A dog may continue to participate in this test after it has earned the titles TD, TDX or VST. Dogs not holding a Tracking Dog title will be given priority for entry in the test by the tracking test secretary."

Bitches in season may participate in accordance with Chapter 2, Section 8, of the Tracking Regulations.

Directions to Draw Site

From I-85 take the Hwy 441 South exit towards Commerce, GA (Exit # 149). Continue on 441 until the Athens Loop, GA Rt. 10 (approximately 20 miles). Turn Right onto the ramp. Exit onto the Oconee Connector (approximately 6 miles from Hwy 441). Keep Right at the ramp. Oconee Connector becomes Mars Hill Road which then becomes Experiment Station Road. McDonalds will on the Right after the traffic light at GA 53.

From Rt. 316 turn Right onto Hwy 53/Hog Mountain Road. Cross over Hwy 78 and at the next light turn Right onto Experiment Station Road. McDonalds will be immediately on the Right.

From Hwy 78 turn Right onto Hwy 53/Hog Mountain Road. At the next light turn Right onto Experiment Station Road. McDonalds will be immediately on the Right.
